REGIONAL COORDINATOR COMMISSION EXAMPLE
REG COORD receives commissions of over \$203,777 the first year and residual commissions of over \$620,478 each year thereafter.
All the Division Mgr does is invite 10 people per week to look at the UFA website and help their recruits invite 6 each week.

REGIONAL DIRECTOR Receive 30% commissions on Level 1 Members, AC's, DC's and RC's +20% overrides on direct AC's and 10% overrides on direct DC's + Bonus Overrides of 6% on Direct AC's and 4% DC's and their downlines levels 2-5. Inviting 10 people each week to the UFA website should average 5.7 Members and 2 people joining as Area Coordinators. Downline AC's invite 6 people each week and average 3.4 members each month and 1.2 people joining as an Area Coordinators.
